### If yes, please outline these comments.:

We challenge the whole concept of gender recognition certificates. We are created by God as male or female and this fact has been recognised throughout history by people in all cultures and countries, by Christians and non-Christians. Each person's sex is evident at birth (and possibly earlier through ultrasounds) and their sex is noted on their birth certificate. This certificate is sufficient. The idea that gender is different than sex is not one that the Bible recognises. We reject any measure to make it easier to legally change gender including reducing the time it takes to pass through the process. No one should be able to quickly change their legally recognised gender. The quicker it is done the more potential their is for the system to be abused, producing safeguarding risks for women, children, and vulnerable adults.

The longer the period of reflection the better. There are many people who have begun gender transition only to deeply regret it. They should not be allowed to change their legally recognised gender quickly. Young people are impressionable and may be being pressured into taking these steps. All should have the opportunity to hear alternative arguments.

# If you wish, please give reasons for your view.:

We oppose any liberalisation of gender recognition including lowering the minimum age. Many 16 year olds are still immature in their thinking. Many of them are still in schools where they are indoctrinated in LGBT teaching- is there any wonder that transgenderism is a fad when it is promoted so forcefully?

There is too much pressure put on young people to conform to this new doctrine and to transition. Lowering the age limit opens the door for further abuse, especially when the proposal is to make the process more hasty at the same time.

# If yes, please outline these comments.:
