# Young Carer Grant: high level statistics to 31 January 2022

### Key Figures

- From 21 October 2019 to 31 January 2022, 8,325 Young Carer Grant applications were received **[Table 1]**.
- Overall, 7,775 applications had been processed by 31 January 2022. Of these, 69% were authorised, 28% were denied, and 2% were withdrawn **[Table 1]**.
- The total value of Young Carer Grant payments issued to clients by 31 January 2022 was £1.6 million **[Table 7]**.

### Frequency of publications

The next publication, covering up to 30 April 2022, will be released in June 2022.

Under the Code of Practice for Official Statistics<sup>1</sup> we publish a timetable of statistical releases for the twelve months ahead<sup>2</sup>.

# Introduction

Social Security Scotland began taking applications for Young Carer Grant on 21 October 2019. This publication provides information on applications and payments for Young Carer Grant from this date to 31 January 2022. It therefore includes figures for over 2 years of applications.

As this publication reports on applications and decisions to the end of January 2022, it spans the period when the Covid-19 pandemic was present in Scotland. Social Security Scotland implemented some service changes in response to the Covid-19 pandemic but has continued to process applications and make payments.

These statistics are being published as experimental statistics. Experimental statistics are defined in the Code of Practice for Statistics as "*new official statistics undergoing evaluation. They are published in order to involve users and stakeholders in their development and as a means to build in quality at an early stage.*" The UK Statistics Authority has not yet assessed these statistics. They have not been designated as National Statistics<sup>3</sup>.

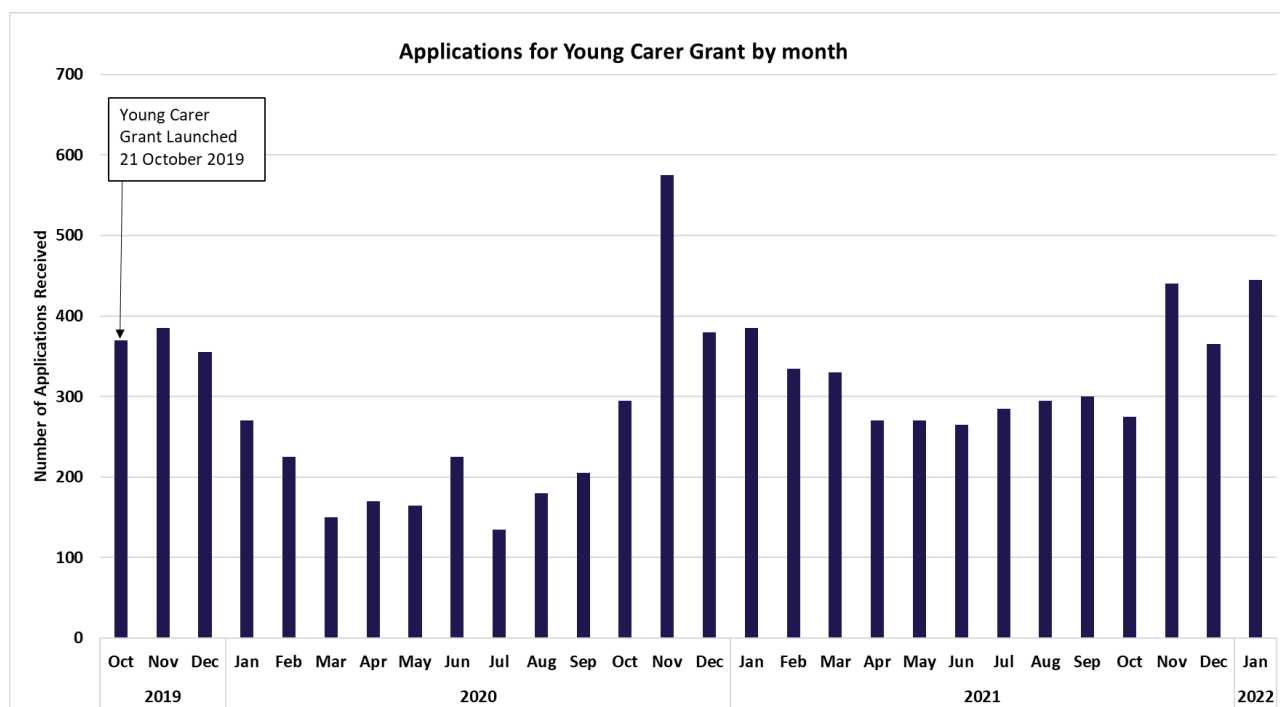
# Main findings

## Applications Received and Processed

- In total, 8,325 applications were received by 31 January 2022, with 440 received in November 2021, 365 in December and 445 in January 2022. **[Table 1, Chart 1]**.
- November 2020 remains the month with the highest number of applications received (575 applications) **[Table 1, Chart 1]**.
- Overall, 7,775 applications had been processed by 31 January 2022. Of these, 69% were authorised, 28% were denied, and 2% were withdrawn **[Table 1]**.
- The number of applications processed in November 2021, December, and January 2022 respectively was 270, 285 and 475 **[Table 1]**.
- Prior to this publication, December 2020 was the month with the highest number of applications being processed (460). January 2022 is now the month with the highest number of applications processed (475) **[Table 1]**.
- The proportion of applications authorised per month has risen in recent months, from 56% in November 2021 to 65% in both December and January 2022. **[Table 1]**.
- Applications denied in the past six months frequently failed the following eligibility:
  - The applicant must be caring for an average of 16 hours per week, over a 13-week period.
  - The applicant must not have been approved for Young Carer Grant within the last year.

By failing the latter eligibility criteria, it means the applicant had already been approved for a Young Carer Grant payment within the last twelve months.

### Application Channel (Method of Application)

- Around 94% of the 8,325 applications received by 31 January 2022 were made online. Around 4% were made through telephone applications. The remaining 2% were made through paper application [Table 2].
- Changes were made in response to the Covid-19 pandemic that meant the full telephony service was not available from 24 March 2020 onwards. A full inbound telephony service was restored from 2 November 2020. Telephony application numbers have remained consistently low since November 2020, in line with numbers seen prior to March 2020.

### Applications by Age Group

- Of the 8,325 applications received by 31 January 2022, approximately 36% were for an applicant aged 16 years. A further 38% were for an applicant aged 17 years, and 24% were for an applicant aged 18 years [Table 3].
- The percentage of applications authorised was highest where the applicant was aged 16 years, at 76%. This compares to 68% authorised where the applicant was aged 17 years, and 67% authorised where the applicant was aged 18 years [Table 3].

### Applications by Local Authority

- Applications were received from young people living in all local authority areas. The highest number of applications were 1,230 from Glasgow City,

which accounts for around 15% of all applications received to the end of January 2022. The next highest was 670 from North Lanarkshire, 590 from Fife and 465 from South Lanarkshire. Figures covering the current financial year to date show a similar trend, with the most applications coming from Glasgow City, Fife, North Lanarkshire and South Lanarkshire **[Table 4]**.

- While the percentage of processed applications authorised was 69% overall, this varied between local authority areas, ranging from the lowest at 63% in Dumfries and Galloway and Midlothian to the highest at 89% in the Orkney Islands **[Table 4]**.
- Information on applications received and processed split by financial year can be found within Table 4.

## Applications by Number of Cared for People

- Around 98% of all applications received were for applicants caring for one person. Less than 1% of applications were for applicants caring for two or three people **[Table 5]**.
- Number of cared for people is calculated using the details provided in applications. It is possible that some applicants will have been caring for more people than they included in their application. See the [about the data](#) section for more information on this.

## Processing Times

- In total, approximately 32% of applications processed between 21 October 2019 and 31 January 2022 were processed within 10 working days. Furthermore, 51% of applications were processed within 15 working days **[Table 6]**.
- Around 14% of applications were processed in between 16 and 20 working days, and 35% of applications took 21 working days or longer to be processed **[Table 6]**.
- The median average<sup>4</sup> processing time for applications processed between 21 October 2019 and 31 January 2022 was 15 working days **[Table 6]**.
- In the last three months, the median average processing time increased from 19 working days in November 2021 to 23 working days in January 2022. This was the highest processing time since June 2020 **[Table 6]**.
- Processing times were calculated by determining the time between an application being received and a decision being made or the application being withdrawn. This includes the time spent waiting to receive evidence from clients to allow a decision to be made, which should be considered when interpreting these processing times. ## Payments

- In total, 5,280 Young Carer Grant payments were issued up to 31 January 2022, with a total value of £1.6 million. Of this, £339,900 was issued in financial year 2019/20<sup>5</sup>, £694,725 was issued in financial year 2020/21<sup>6</sup> and the remaining £574,706 was issued in the current 2021/22 financial year<sup>7</sup> **[Table 8]**.
- On 1 April 2021, the value of payment for Young Carer Grant was updated from £305.10 to £308.15. Successful applications received between 1 April 2020 and 31 March 2021 received £305.10, with successful applications prior to 1 April 2020 receiving a payment of £300.
- The value of payments issued decreased from £53,310 in November 2021 to £49,304 in December before increasing to £88,131 in January 2022. The highest monthly value of payments made to date was in March 2021, where the total value of £104,344 was issued **[Table 8]**.
- At the local authority level, the highest total value of payments were £238,539 made to young carers in Glasgow City, £128,293 to North Lanarkshire, and £110,153 to Fife. Figures covering the current financial year to date also show a similar trend, with the highest value of payments being paid to coming from Glasgow City, North Lanarkshire and Fife **[Table 7]**.
- A breakdown of payments by local authority area and financial year can be found in Table 7.
- The total number of clients who have received payment as of 31 January 2022 was 3,890. Of these, 2,575 clients had received one payment, 1,245 clients had received two payments and 70 clients had received three payments **[Table 9]**.

## Re-determinations and Appeals

- Management information indicates that 135 re-determinations were requested by 31 January 2022. This represents around 1.7% of the total number of Young Carer Grant applications processed during this period **[Table 10]**.
- By 31 January 2022, 135 re-determination requests had been decided. Of these, 70 were allowed or partially allowed, while 45 were disallowed and 20 were withdrawn **[Table 10]**.

- The median average<sup>8</sup> response time for re-determinations that were closed up to 31 January 2022 was 9 working days. This excludes re-determinations that were withdrawn by the client **[Table 10]**.
- Fewer than five appeals that were assessed to be valid requests were received by 31 January 2022. Management information on appeals has therefore not been included in this publication to prevent the disclosure of small cohorts.

# Background to Young Carer Grant

On 20 September 2017, the First Minister announced a new package of support for young carers in Scotland. This package included a cash payment for young carers providing 16 hours or more of care a week to someone normally paid a qualifying disability benefit. In accordance with the powers set out in the Social Security (Scotland) Act 2018<sup>9</sup>, Scottish ministers set out regulations<sup>10</sup> for the new Young Carer Grant on 15 October 2019.

Social Security Scotland is the executive agency of Scottish Government responsible for delivering social security benefits for Scotland. The Agency began taking applications for Young Carer Grant on 21 October 2019.

## Young Carer Grant

Young Carer Grant is a payment that can be applied for annually by young carers aged 16, 17, and 18 who care for someone normally paid a qualifying disability benefit. The payment is a flat rate of £308.15 that can be applied for once a year. The payment is in acknowledgement of the young person's carer role and is intended to help them access life opportunities that are the norm for many other young people. Young carers can spend this money as they choose.

## Eligibility

To qualify for Young Carer Grant, applicants must meet all of the eligibility criteria below:

- Applicants must be 16, 17 or 18 years of age at the time of applying.
- Applicants must be providing care to a person(s) who is normally paid one of the following benefits:
  - the daily living component of Personal Independence Payment (PIP)
  - the daily living component of Adult Disability Payment (ADP)
  - the middle or highest care rate Disability Living Allowance (DLA), including Disability Living Allowance for Children
  - the middle or highest care rate of Child Disability Payment (CDP)
  - Attendance Allowance

- Armed Forces Independence Payment
- Constant Attendance Allowance
- If the person cared for gets Constant Attendance Allowance they need to be getting either:
  - Industrial Injuries Disablement Benefit (at or above the normal maximum rate), or
  - War Disablement Pension (at the basic rate)
- The applicant must be caring for an average of 16 hours per week, over a 13-week period. Applicants can combine hours spent caring for up to three people to meet this criterion.
- The applicant must not be paid for the care they provide or be providing the care as part of a volunteering scheme.
- The applicant cannot be applying for, or be in receipt of, Carer's Allowance at the time of application.
- The applicant must not have been approved for Young Carer Grant within the last year.
- The cared for person must not have been part of an approved application within the last year.

## **Application and Decision Making Process**

Applications can be made online, by phone, and by paper form ('application channel').

Social Security Scotland processes each application received and makes a decision whether to approve or deny the application. An application will be denied if the client is not eligible to receive Young Carer Grant. An application will be authorised if the applicant is eligible and provides the appropriate evidence to receive Young Carer Grant. Applicants may also withdraw their application before a decision is made.

As part of the application process, applicants are required to provide additional evidence confirming their address. Once an application has been received, Social Security Scotland will write to applicants asking them to either post this evidence or upload it online directly to Social Security Scotland. Applicants can also post or upload evidence proactively when making an application. Once this evidence has been received, Social Security Scotland aims to make a decision as soon as possible with payments following soon thereafter.

In this publication, application processing time is calculated as the number of working days from the application being received by Social Security Scotland to the date that a decision was made by a client advisor or the application was withdrawn. We did not include time to make payments within processing times.

## Applying Outside of Scotland

On 23 December 2020, Scottish ministers set out regulations<sup>11</sup> that allows eligible young carers living outside the UK in the European Economic Area and Switzerland to also receive Young Carer Grant.

Applicants from the European Economic Area and Switzerland can apply by phone and by paper form. To determine whether they are eligible for Young Carer Grant while living outside of Scotland, they will need to go over additional residency details for Social Security Scotland to make a decision. The three residency tests they need to cover are:

- competent state
- habitual residency
- genuine and sufficient link to Scotland.

Applicants from the European Economic Area and Switzerland are required to provide additional evidence that also confirms their identity along with the evidence confirming their address. This evidence needs to be submitted to Social Security Scotland once an application has been made.

## Re-determinations and Appeals

Applicants have the right to ask Social Security Scotland to reconsider a decision if their application is denied, or if they think the amount they are going to be paid is wrong. This is known as a re-determination. A request for a re-determination should be made within 31 calendar days of being notified of the initial determination. This is extended to up to 1 year under extenuating circumstances. Social Security Scotland then has 16 working days to make the new determination. Applicants also have the right to appeal to a Tribunal if they do not agree with Social Security Scotland's re-determination, or if Social Security Scotland is not able to make a re-determination within 16 working days.

## Coronavirus (Scotland) Act 2020<sup>12</sup>

On 1 April 2020, the Scottish Parliament approved emergency legislation to help businesses, public services and people through the Covid-19 pandemic.

Measures include helping to ensure that Social Security Scotland clients are not disadvantaged because of the coronavirus outbreak and are able to claim assistance to which they are entitled and which they may have missed if late applications were not allowed.

Changes, which came into force on 7 April 2020, include temporarily time limits for Young Carer Grant applications. Where a young carer could not apply before they turned 19 due to Covid-19, they will still be able to apply for Young Carer Grant with their application being treated as made on time. The measures temporarily relax time limits for Young Carer Grant in relation to:

- making an application for assistance
- a request by a client for a re-determination
- a decision on a re-determination
- appealing to the First-tier Tribunal

Young carers will continue to benefit from a relaxation of the timescales to apply for Young Carer Grant, where the delay is related to Coronavirus, for as long as this affects young carers.

The temporary extension to the deadline for Social Security Scotland to process re-determinations expired for new re-determination requests on 30 September 2021.

# About the data

## How the Data is Collected

The data in this publication is sourced from Social Security Scotland's case management system. The system holds information on all applications, outcomes, and payments. Data about the applicant and the person(s) they care for is collected through the online application form, or is entered by client advisors during telephone applications or the processing of paper applications. Information about the application outcome and payments is created in the case management system as an application is processed.

The information is held across multiple tables within the system. 100% extracts of administrative data are taken from this system every day for internal reporting purposes. Data cuts combine information from the different tables in the system into one daily extract that includes details of all Young Carer Grant applications made since 21 October 2019.

To take into account backdating and delays between applications being authorised and payments being made, the data cut from 1 March 2022 has been used to produce statistics on applications received and decisions made up to 23:59 on 31 January 2022. Later data cuts may include additional retrospective changes to application details, including corrections to details in the case management system, and changes that have resulted from re-determinations and appeals.

Where a re-determination or appeal has been requested but not decided, decision date, outcome, payment date, and payment value will be updated to reflect information about the re-determination or appeal, rather than the original application. If a re-determination or appeal has been decided, the data in this publication will show the decision date, outcome, payment date, and payment value according to the new decision.

Detailed management information on re-determinations and appeals has been used to produce statistics on the number of re-determinations received and decided up to 23:59 on 31 January 2022. Suppression has been applied to this data to prevent the disclosure of individuals or small cohorts.

Management information regarding appeals has not been included in this publication due to fewer than five appeals that were assessed to be valid requests being received during the period covered. In future updates to these statistics, information on appeals will be included, subject to the disclosure control of small cohorts.

Within our statistical reporting, key dates are used to assign applications received, applications processed and payments issued to time periods. This is a different methodology to that used in financial reporting and, as a result, there may be differences in the values reported for a given time period.

## Quality Assurance

The data used to produce the official statistics are the same as the data extracted from the case management system on a daily basis that is used for internal reporting within Social Security Scotland. As such, the data is checked daily for consistency with previous extracts (i.e. do applications, decisions, and payments figures increase as expected over time, and are they in proportion to each other) and compared to other sources of information such as the number of payment instructions reported by the finance team.

Additional quality assurance and cleaning has been carried out on the variables used in the official statistics:

- check for duplicate and missing application references
- check that application dates, processing times, and payment times are within the expected ranges
- check that payment date is present where a payment value is present
- check any postcodes that do not match to local authority areas – see [Geography](#) section
- removal of a small number of test applications which were used to test the case management system.

Once the data is aggregated and copied into the publication and supporting Excel tables, the final statistics are quality assured by a different member of the statistics team. The lead statistician checks the final documents.

## Revisions

Each updated publication of Young Carer Grant statistics can include revisions of numbers of applications received, processed, processing times and payment values going back to October 2019. This is because each time figures are published they will be based from a new 100% data cut from the case management system, which can include retrospective changes to data going back to October 2019 as described in the [How the data is collected](#) section. Months that are more recent tend to be subject to a greater degree of revision than more distant ones.

## Data Quality

### Rounding and Disclosure Control

Application and outcome figures have been rounded to the nearest five for disclosure control. Data has been suppressed where it would disclose fewer than five applications or payments.

### Missing and Duplicate Applications

The data comes from 100% data cut of the case management system.

The data cut was checked for applications where the fields relating to application date and the outcome and payment of the application were blank. These applications would represent temporary 'prospect cases', which are created when clients contact Social Security Scotland without a National Insurance number, and are later replaced once a National Insurance number is received from the applicant. Any such applications are therefore duplicates and would be excluded from the statistics.

Clients may make repeated applications to Young Carer Grant in certain circumstances. For instance, if their initial application is withdrawn or denied. This means that there can be several applications from the same client in the data cut. For this publication, we have retained all of these applications.

### Unverified Information from Application Form

Information about the client and the person(s) being cared for is taken from the application form completed by the client or by a client advisor over the telephone. This information may contain errors because it has not been verified by comparison to other sources of information such as records held by the Department for Work and Pensions. This means, for example, that it is possible to have authorised applications where the original application form did not include complete details for the applicant but was later amended as the application was processed.

### Application Authorisation and Payment

In this publication, the date that applications were processed by client advisors is the date used to produce statistics of processed applications by month. After applications are authorised for payment by client advisors, a manager approves the decision, and then a payment is issued. In some cases, payments will be issued on the same day that payments are authorised by client advisors. In other cases, there can be a delay before payments are issued. Clients should receive money in their nominated account within four working days after payment is issued.

In this publication, we report on the value of payments that have been issued by the end of each month and not the payments successfully received by the applicants.

A very small number of payments are made manually to clients. These manual payments do not appear in the administrative data extracts used for this publication and are therefore not counted in the payment statistics.

### Application Channel

Application channel is automatically entered into the case management system for online applications, and manually entered for applications taken by phone or paper. If ever an application channel has been manually entered incorrectly, the application channel will be classed as 'unknown'.

### Number of Cared for People

The number of cared for people is entered into the case management system using the details provided by the applicant. This figure represents the total number of cared for people included in the application. However, it may not be a reflection of the total amount of people the applicant cares for. For example, an applicant may provide care to three people but may only choose to provide details of one of these individuals in their application if they care for that person for 16 hours or more per week.

### Geography

Applications are assigned to local authority by postcode using a Scottish Government lookup file. For some applications, the postcode will not match to the lookup file. This can be because the postcode is not in a Scottish local authority, or because the postcode has been introduced too recently to appear on the lookup file, for example if a property is in a new development. For postcodes that could not be matched to a Scottish local authority, the postcode area was used to check whether the postcode was in Scotland or elsewhere. Non-matching postcodes from Scottish border postcode areas (postcodes starting 'DG' and 'TD') were also checked individually and assigned to Scottish local authority areas or as 'non-Scottish postcodes' manually.

A very small number of applications did not include address information and therefore could not be matched to a local authority or country.

## Re-determinations

Application decision dates, outcomes, and payment amounts are updated to reflect information about re-determinations and appeals as described in the [How the data is collected](#) section. Information in tables should therefore be viewed as the final decision, outcome, and payment value after a re-determination request or appeal has been received and/or decided. This excludes the processing times table, where applications with re-determinations and appeals have been removed from processing time calculations. Due to the small number of re-determinations received during the period this publication covers, it is unlikely that re-determinations will have a significant impact on the data included.

## Processing Time

Processing time is the number of days from the application being received to a decision being made or the application being withdrawn. It includes time spent waiting to receive evidence from applicants through online upload or by post, but does not include additional time to make payments. It is calculated in working days. Weekends and public holidays are excluded from calculations, even if applications were processed by staff working overtime on these days. The time of day that an application was received or processed is not taken into account.

Processing times calculated do not include any applications that are flagged as having had a re-determination request because the decision date for these applications will represent the re-determination decision date, which can be some time after the original decision date. The number of applications in the processing times table is therefore lower than the number of applications shown as processed or decided in other tables.

Re-determinations are a very small proportion of the total applications processed, and the initial average processing times for applications that go on to re-determination or appeal compared to other applications should not differ from all other applications. Therefore, removal of these should not affect the average processing times shown in the table.

Processing time is only calculated for applications that were decided within the period being reported on. Data is presented by the month of decision rather than month the application was received.
