This is passed from team to team, so that we always know what has happened in the last 24 hours, and what might come up in the next.

The UKFMC (United Kingdom Fisheries Monitoring Centre), based at Victoria Quay, Edinburgh, is a 24/7, 365 days a year operation, staffed by British Sea Fishery Officers (BSFOs) who keep an eye on the activities of all fishing vessels in Scottish waters, and all Scottish vessels, wherever they may be in the world.

Unlike our colleagues who work in our coastal offices and at various fishing ports throughout the country, we don't get out much - we tend to deal with emails and telephone calls coming in – although these can generate quite a bit of follow up work! We also constantly monitor the various Protected and Restricted areas around the Scottish coast, making sure that our marine ecosystems are given the protection they need.

Whether it is dealing with issues or requests from other Fishing Administrations in the rest of the UK, anywhere in Europe with a fishing fleet, or further afield – such as Norway and The Faroe Islands – or answering phone calls from disgruntled skippers whose laptops have decided not to work (after all, sea water and electronics don't mix well all the time) there is rarely a dull moment in this place.
