Comments Glasgow City Council Social Work Services welcomes the establishment of a forum to give adult survivors abused in residential care as children an opportunity to be heard. Within Glasgow we have a specific service for childhood/adult victims of sexual abuse and have experience of working with adult survivors who were abused while in the care of the local authority/other child care organisations.
In addition we have a specific senior officer who has responsibility of co-ordinating all historical abuse allegations. This worker has had direct contact with adults who have come forward to tell about their abuse experiences as children while in the care of the local authority and child care organisations.
From our experience in Glasgow such a forum would give adult survivors a positive forum to talk about their experiences.

Comments Many of the adults that social work services have come in to contact with have issues with regard to "authority figures" for a range of valid reasons. This means that they find it hard to trust such bodies and may feel reluctant to engage with a forum if this sat within the Government.
Victims of abuse may find it easier to engage with the Forum if it is seen not be a Government body.

Comments The forum should be for all abuse survivors of in care abuse. For those adults whose experiences were positive while in the care of the local authority, it may be useful to gather this information to gain a balanced overview of residential child care at that time. However, colleagues who attended a Time to Heard session previously indicated that adults who had not been abused whilst in local authority care were significantly impacted by victims accounts, and for survivors it was hard to hear how others had been treated when their experiences had been abusive.			
Indeed, this may only add to the victims feelilngs that this was their fault. This concern was expressed at the TTBH event.

Q7. What other support do you consider that participants would benefit from before, during and after the Forum?

Comments Support for people in such situations is vital. However, it has to be recognised that many will not have good family support and this cannot be relied upon. Lack of good support is often an issue for survivors. The national forum should have the responsibility of directing abuse survivors to appropriate services/supports. We should not assume that abuse survivors have support, this needs to be actively checked.
Workers attending the TTBH session commented that the impact on survivors during the session was overwhelming. The long term impact of abuse has to be recognised and the support offered accordingly. For some people, attending the forum may be the first time they have talked about their abuse and their awareness of the impact on their lives may just start at this point. Therefore, it is essential that supports are made available for all survivors involved in the forum.
 Q8. Do you think that the participants should be protected from legal action in connection with their work for the Forum? Yes X No No Preference
Comments Adults will participate in a process if they are fearful that their involvement could result in legal action. However, at the outset it has to be made clear that if information is shared that suggests that someone may be a risk of harm, then this information may require to be disclosed to ensure the safety and well-being of that individual and to prevent further abuse in the future.
It is unclear why an individual would need to be protected from legal action, unless they had committed an offence. If this relates to the behaviours of individuals as children, this is likely to be a very difficult area to give clear guidance.
