The Forum needs to operate within a general climate of confidentiality (although full confidentiality could never be assured as information would require to be passed to the police if the Forum became aware of an ongoing risk to someone).

The Forum will have a duty to report any ongoing crime that is apparent from the hearings.

#### <u>Adult Community Mental Health – NHS Ayrshire and Arran</u>

This would potentially lead to blurring of boundaries for some. The parameters should be explicit around what constitutes confidentiality and the types of situations that would require disclosure to third parties.

All survivors require access to the same opportunities and support.
