All institutions that provided residential care for children must be included to ensure all adults who want to take part have the opportunity, to ensure equality of access to support for all adults who experienced childhood abuse, if they want to the opportunity.
For example, SCoD has produced a number of DVDs recording the experiences of Deaf BSL users throughout their lives. Several of the people who took part told of

the abuse they suffered while boarders at Deaf schools. It is important that Deaf BSL users who were often sent away to Deaf boarding schools have the same opportunity as adults who were placed in residential units/organisations by the State, and adults who as children were sent away to residential units/organisations/institutes by their families also have equality of opportunity to tell their stories and receive support.

It is the opportunity to be heard and be believed that is important and part of the "healing process" so if the government is to set up such a Forum, it is important it is open to all adults that want the opportunity to tell.

The support offered should be appropriate to the person who is doing the telling. For example, it might be that a Deaf BSL user will need access to accessible counselling before and after the event.
