The Scottish Independent Advocacy Alliance (SIAA) is a membership organisation which promotes, supports and defends Independent Advocacy in Scotland. It aims to ensure that Independent Advocacy is available to any vulnerable person in Scotland.

The right to Independent Advocacy for those with mental disorders or who are potentially at risk is enshrined in Scottish legislation. However, Independent Advocacy can also have a key part to play in supporting other vulnerable groups such as black and minority ethnic groups and children and young people, amongst others.

Independent Advocacy organisations do not provide any services other than advocacy. They are separate organisations in their own right, are financially independent, and as free as possible from any conflicts of interest.

If the forum is to fully capture the experiences of all adults who have experienced abuse in residential care then all of the above must be included.

Q7. What other support do you consider that participants would benefit from before, during and after the Forum?

Participants in the forum should have access to experienced sexual abuse counsellors and other forms of therapeutic support, as needed. The individual might also benefit from access to Independent Advocacy.

Consideration should be given to setting up a collective advocacy group for survivors which would allow individuals to meet others with shared experiences. The group might also decide to raise awareness, lobby and campaign to change policy and legislation that would help to prevent future occurrences.
