POSSIBLE MARINE PROTECTED AREAS – CONSULTATION RESPONSE

We have read with interest the consultation documents on the possible Marine Protected Areas for Scottish waters and I am pleased to set out some comments on behalf of Aggregate Industries. These comments are referred to in the attached consultation questionnaire.

Aggregate Industries, through the acquisition of Foster Yeoman Limited, operates the UK's only coastal "super quarry" at Glensanda, Morvern. The site is on the Morvern Peninsula, on the west side of Loch Linnhe and is totally reliant on the sea for its day-to-day operation. All aggregate products are exported by ship, and all equipment, consumables and employees are transported via Loch Creran and Loch Linnhe by boat from the company's depot at Rhugh Garbh, Barcaldine.

Glensanda Quarry directly employs around 200 people and generates a total business turnover in excess of £40 million per annum. Annual revenue expenditure at the site is around £20 million, of which £5 million is paid as wages and salaries. The majority of the workforce lives within daily travelling distance of the site. In an area where employment is dominated by seasonal tourism and the public services Glensanda represents one of, if not the, most important sources of private sector industrial employment on the west coast of Scotland.

Glensanda is now an internationally important source of construction aggregates, supplying markets within Scotland, England and Europe. It is the largest hard-rock quarry in Europe and the sixth largest dry bulk port in the UK. As traditional sources of aggregates elsewhere become increasingly difficult to maintain the output at Glensanda is expected to rise from the current 6 million tonnes p.a. towards the maximum permitted 15 million tonnes per annum.

All the crushed rock from the quarry is distributed by sea in three company owned ships, two of 95,000 dwt and one of 36,000 tonnes dwt. Other vessels are chartered as and when required. Foster Yeoman Limited is the Statutory Harbour Authority for Glensanda with harbour limits extending out into Loch Linnhe, as provided for in the Glensanda Harbour Order Confirmation Act 1985 and associated Byelaws. The Act and Byelaws exist to protect and govern operations within the Harbour area which must take precedence over any proposed planning policy. Many of the port destinations for Glensanda ships are in Europe and the south east of England for which the optimum route is via the Sound of Mull and the Minch, but there is also an increasing proportion of output shipped into Scottish markets.

The two possible MPA areas of concern are the Loch Sunart to Sound of Jura and Loch Creran. It is important to note that the features of primary interest (skate and flame shell beds respectively) are present in spite of the presence of Glensanda Quarry for the last thirty years.

Loch Sunart to the Sound of Jura

The area covered by the Loch Sunart to the Sound of Jura possible MPA includes the Sound of Mull and the Firth of Lorn, both primary shipping routes serving the Port of Glensanda and Glensanda Quarry. It is crucial that the importance of the Sound of Mull and Firth of Lorn as shipping routes is recognised in the documentation accompanying the designation. Of equal importance is the ability to anchor and moor in Loch Linnhe. Although the Management Options document recognises that moorings and anchorages are unlikely to affect skate and no additional management is recommended, the document should go further in recognising the importance of the possible MPA for shipping activities associated with Glensanda Harbour. The boundary of the possible MPA area across Loch Linnhe appears to have been drawn rather arbitrarily and bisects the Glensanda Harbour limits. The attached plan shows the harbour limits together with a suggested revised possible MPA boundary, which would remove any conflict between management of the possible MPA and Harbour operations. It is strongly recommended that this suggested boundary be adopted.

Loch Creran

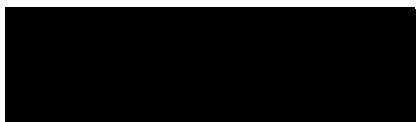
As previously mentioned, Aggregate Industries operates a depot at Rhugh Garbh, Barcaldine on Loch Creran, which is used to transport employees, equipment and consumables by boat to Glensanda Quarry. This is the only logistics route available for these activities, since there are no roads to or from the Quarry.

Loch Creran is noted for its flame shell beds, which occur in two distinct areas of the Loch at Eriska Narrows and Creagan Narrows. Vessels from Rhugh Garbh leave the Loch via Eriska Narrows, but do not head up the Loch towards Creagan. Vessels including a catamaran, various tugs and barges moor on both north and south banks of the Loch well away from the flame shell beds. From time to time these moorings can be lost and may need to be replaced. As is normal good practice, a diver survey is carried out and a report submitted with any marine license application for a new mooring.

Again, it is crucial that the designation recognises the importance of the Loch for commercial shipping associated with Glensanda Quarry.

We trust the above together with the enclosed provides a sufficiently detailed response to the consultation, but should you require any further information, please do not hesitate to contact me.

The Scottish Government Consultation Process
