DETERMINATIONS UNDER THE POLICE SERVICE OF SCOTLAND (PROMOTION) REGULATIONS 2013

- 1) The Scottish Ministers, in exercise of the powers conferred by regulation 4 of the Police Service of Scotland (Promotion) Regulations 2013 ("the Regulations") determine that:
 - a) the application process for entry to the qualifying diploma course is as specified in <u>Annex 1</u>; and
 - b) the syllabus for the qualifying diploma course is as specified in Annex 2.
- 2) The Scottish Ministers have consulted and shared a draft of this determination with the persons mentioned in section 54(2)(a)(i) to (vi) of the Police and Fire Reform (Scotland) Act 2012 and have considered any representations made.
- 3) Expressions used in these determinations which also appear in the Regulations have the same meanings as in the Regulations.
- 4) These determinations come into force on 1st April 2013.

Annex 1 To first page Regulation 4(5)(a)

Application process for commencing the qualifying diploma course.

- 1) A constable who wishes to take the qualifying diploma course must submit an application to the chief constable to be accepted onto that course.
- 2) The chief constable must ensure that sufficient resources are provided so that the selection process for applicants to commence each qualifying diploma course is carried out in a fair, open and transparent manner.
- 3) The chief constable must put in place arrangements for consideration of applications submitted under paragraph (2) and those arrangements must involve fair, open and transparent competition.
- 4) Following consideration of a constable's application, the chief constable must give the constable notice of whether their application is accepted or rejected, and if the application is rejected must provide reasons for that decision.

Annex 2 To first page Regulation 4(5)(b)

Syllabus for the qualifying diploma course.

- 1) The syllabus for the qualifying diploma course is to consist of the 4 modules and 9 higher national units mentioned in paragraphs 2 and 3 respectively.
- 2) The modules are:
 - i) Policing in Scotland
 - ii) Managing Dilemmas
 - iii) Achieving Success through Management
 - iv) Leading People
- 3) The higher national units are:
 - i) Developing Skills for Personal Effectiveness
 - ii) Contemporary Policing
 - iii) Criminal Justice System in Scotland
 - iv) Professional Knowledge in Policing
 - v) Professional Ethics in Policing
 - vi) Decision Making
 - vii) Organisational Management
 - viii) People Management
 - ix) Leadership
- 4) Within the framework of the 4 modules the Scottish Police Authority will determine the detailed content of the 9 higher national units.
