1. Welcome, introductions and apologies

- 1.1 IR welcomed members to the meeting.
- 1.2 IR confirmed that following agreement from group members, the minutes from previous meetings are now available on the Scottish Government website.

2. Note of meeting 27 February 2018

2.1 A number of amendments were suggested. The minutes will be updated and circulated for approval before being added to the website.

AP01 – CW to amend Feb minutes, reissue to group for approval and publish on SG website.

3. Actions from previous meeting

3.1 The Group noted actions 1 -6 had been cleared.

4. SEEMiS update and guidance

4.1 AW from SEEMiS was unable to attend today's meeting to provide an update. However, IR confirmed that the proposed changes had been submitted for consultation with the LA's through the SEEMiS Forum. IR confirmed that the full list of the group's proposed changes were also submitted. Following this, the Governance Group met on the 13 March to discuss

the proposals. IR informed the group that a telephone discussion had taken place between members of the SEEMiS Governance Group, MF and CW on the 15 March following the SEEMiS Governance Group meeting to discuss the proposed changes.

- 4.2 CW confirmed that during the telephone discussions with SEEMiS, the possibility for additional SEEMiS resources to be allocated to assist with implementing these changes quicker was discussed. SEEMiS agreed to consider this option and agreed to send in a proposal to cover this. CW had only just received this proposal from SEEMiS prior to this meeting which contained quite significant costs. CW was unable to share the detail of this proposal with the group at this time as this has still to be discussed with senior SG officials. An update would be provided to the group as soon as possible.
- 4.3 A discussion took place about any alternatives to SEEMiS that are available. CW clarified that officials from ES and SG had met with SEEMiS colleagues in September last year to discuss the process of making changes to the Bullying and Equalities module. As this is the most commonly used system by all schools then it was the most obvious system to be used. There is no other alternative national system available.
- 4.4 CW confirmed that if it was decided to accept the SEEMiS proposal which included additional costs, a contract would be issued with SEEMiS for the work to be undertaken.
- 4.5 The group agreed a number of changes to be made to the guidance. The guidance will be updated and circulated to the group. Following this, CW will send to APS shortly for conversion to PDF document which will reflect the colours/format of 'Respect for All: The National Approach to Anti-bullying for Scotland's Children and Young People'.

AP02 – CW to update guidance and reissue to group

4.6 Once the latest version of the guidance is available and issued to the group, GW offered to consult with colleagues within Fife local authority and draft some FAQ's to support the guidance. This would be available online, perhaps on the respect*me*/ES website and a link would be provided in the guidance.

5. Next steps/practical implications

- 5.1 MF confirmed that ADES have agreed to Chair the Operational Group and secretariat would be provided by SG. Representatives from local authorities will be asked to sit on this group; this could include Deputy HT's/Guidance staff and also representation from Trade Unions.
- 5.2 It was agreed that following the final recommendations being submitted to the Deputy First Minister, the Recording and Monitoring Group would continue to meet on a six monthly basis. The Operational Group would provide feedback to the main group.
- 5.3 A suggested list of draft Group Recommendations had been issued to the group prior to the meeting. This paper was discussed at the meeting and a number of amendments were agreed.

AP03 – CW to update and reissue recommendations to the group.

5.4 It was agreed that the evaluation would be discussed at the next meeting.

6. AOB

- 6.1 CW and MF updated the group of the recent training events on 'Respect for All' and 'Included, Engaged and Involved Part 2' which were delivered by SG and ES in partnership with respect me and LGBT Youth Scotland. Six training events took place across Scotland on a Regional Improvement Collaborative basis during Feb/March. All these events were very well attended and initial evaluations have been very positive.
- 6.2 The next meeting will take place on Wednesday 2 May from 9.30-1.30pm at Victoria Quay. An additional meeting may take place on the 30 May from 1-4pm at Optima House, Glasgow if required.
