
RECORDED CRIME IN SCOTLAND, 2011-12 26 June 2012



1. Introduction

- 1.1 This bulletin presents statistics on crimes and offences recorded and cleared up by the eight Scottish police forces in 2011-12. It forms part of the Scottish Government series of statistical bulletins on the criminal justice system. Statistics on crimes and offences recorded by the police provide a measure of the volume of crime with which the police are faced.
- 1.2 The statistics on crimes and offences are used to inform National Outcome 9 'we live our lives safe from crime, disorder and danger'. The statistics are also used by a wide variety of users and stakeholders to monitor trends, for policy research and development, and for research purposes.
- 1.3 Crimes recorded by the police in Scotland decreased from 323,247 in 2010-11 to 314,186 in 2011-12, a decrease of 3%. The number of offences increased by 3%, from 530,249 in 2010-11 to 544,033 in 2011-12.

2. Main points

- There has been a decrease in the number of crimes recorded in three of the five crime groups, with Non-sexual crimes of violence, Crimes of dishonesty and Vandalism (including Fire-raising and Malicious mischief) decreasing between 2010-11 and 2011-12 (Table 1).
- The number of Non-sexual crimes of violence recorded by the police decreased by 17% between 2010-11 and 2011-12, to a total of 9,533 (Table 1).
- The number of Sexual offences increased by 10% from 6,696 in 2010-11 to 7,359 in 2011-12 (Table 1). The implementation of the Sexual Offences (Scotland) Act 2009 on 1 December 2010, resulted in a redistribution of Group 2 crimes among the subcategories. Comparisons over time should therefore be treated with caution.
- The number of Crimes of dishonesty decreased by 1% to stand at 154,337 crimes in 2011-12 (Table 1).
- Recorded crimes of Vandalism (including Fire-raising and Malicious mischief) decreased by 8% to total 75,201 in 2011-12 (Table 1).
- In 2011-12, the police recorded 544,033 offences, an increase of 3% from the number of offences recorded in 2010-11. The increase in the number of offences was largely due to a substantial increase in the number of recorded Speeding offences (Table 2).
- The clear-up rate for all recorded crimes in 2011-12 was 49%. This figure has remained constant since 2008-09 (Table 3).
- The clear-up rate in 2011-12 for Non-sexual crimes of violence was higher than in 2010-11, increasing from 72% to 75%. The clear up rates for Sexual offences (67%) and for Miscellaneous offences (84%) increased by 1 percentage point each in 2011-12. The clear up rates for Crimes of dishonesty (37%), Vandalism (including Fire-raising and Malicious mischief) (25%) and Other crimes (98%) remained unchanged from 2010-11 (Table 3).
- Seven of the eight police forces showed a reduction in the number of crimes recorded in 2011-12 compared to 2010-11, the exception being Strathclyde Police where there was an increase of 1%. For Northern Constabulary the number of crimes recorded remained broadly the same as in 2010-11, the reduction being less than 1%. Among the other six police forces, the scale of reduction ranged from 4% for both Central Scotland Police and Lothian and Borders Police, to 16% for Tayside Police (Table 5).
- Although there was a 10% increase in the total number of Sexual offences recorded in Scotland in 2011-12, there were substantial differences between police forces. Increases ranged from 7% for Tayside to 52% for Dumfries and Galloway. But the actual numbers of Sexual offences recorded by Dumfries and Galloway Constabulary are relatively small with the increase being from 99 in 2010-11 to 150 in 2011-12. Decreases were recorded for Fife (12%) and

Northern (14%). The figures for Grampian remained broadly the same in 2011-12 compared to 2010-11 (Table 5).

3. Commentary: Introduction

- 3.1 The term "crime" is *generally* used for the more serious criminal acts; the less serious are termed "offences". The distinction is made only for statistical reporting purposes and the "seriousness" of the offence is *generally* related to the maximum sentence that can be imposed.
- 3.2 The introduction of the Scottish Crime Recording Standard (SCRS) in 2004-05 has helped maintain a consistent approach to recording crime. As anticipated this has increased the numbers of minor crimes recorded by the police, such as minor crimes of Vandalism and minor thefts. However, it was not anticipated that the SCRS would have a notable impact on the figures for more serious crimes such as Serious assault, Sexual assault, Robbery or Housebreaking.
- 3.3 Unfortunately it was not possible to estimate the exact impact of the new recording standard on the recorded crime figures because around the time that the new standard was implemented, police also introduced centralised call centres which encouraged the reporting of incidents to the police.
- 3.4 The Scottish Crime and Justice Survey (SCJS) 2010-11 provides a complementary measure of crime compared with police recorded crime statistics. The survey provides information on the criminal justice system, on people's experience of civil justice problems and people's perception of crime. It also provides estimates of progress for two of the 50 national indicators in the Scottish Government's National Performance Framework: Improve people's perceptions about the crime rate in their area and Reduce crime victimisation rates. The Scottish Crime and Justice Survey can also provide an estimate of the proportion of crimes not reported to the police. In 2010-11, it was estimated that 39% of crimes, as defined by the SCJS, were reported to the police (Section 6).

3.5 There have been no major legislative changes throughout 2011-12 which impact on the comparability of the statistics.

On 1 March 2012, the **Offensive Behaviour at Football and Threatening Communications Act 2012** was implemented. The Act introduces two new offences, Offensive behaviour at football and Threatening communications. These two offences are included in the Breach of the peace etc. category throughout the bulletin.

There were a number of legislative changes throughout 2010-11 which have affected the comparability of some crime groups with past years.

On 6 October 2010, section 38 of the **Criminal Justice and Licensing (Scotland) Act 2010** was implemented. This introduced a new statutory offence of Threatening or abusive behaviour. Unlike the common law offence of Breach of the peace, where case law has decreed that it is necessary to show

a 'public element' to the conduct, there is no requirement in the new legislation to demonstrate the offending behaviour was in a public place.

Section 39 of the 2010 Act introduced the new offence of "Stalking". Formerly conduct which constitutes this new offence would also have been recorded under the common law offence of Breach of the peace.

The offences of Stalking and Threatening and abusive behaviour are included in the Breach of the peace etc. category throughout the bulletin. Caution should therefore be taken when comparing this category with previous years. For further information please see Note 7.15.

The **Sexual Offences (Scotland) Act 2009** came into force on 1 December 2010. The Act was passed following widespread media and academic criticism of the previous law in Scotland surrounding rape and other sexual offences, particularly the gender specific nature of the common law offence of rape.

The Act replaces a number of common law crimes including Rape, Clandestine injury to women and Sodomy with new statutory sexual offences. The Act provides a statutory description of consent, which is defined as free agreement and provides a non-exhaustive list of factual circumstances during which consent will be deemed to be absent.

The Act created a number of new 'protective' offences, which criminalise sexual activity with children and mentally disordered persons. There are separate offences concerning young children (under 13 years) and older children (13-15 years).

The new legislation will only apply to offences committed from 1 December 2010. Any offences committed prior to this date will be recorded using the previous legislation.

The new legislation resulted in some increases in Sexual offences. However, it is likely that the effect will be to change the distribution of these crimes among the subcategories. For example, some crimes previously categorised as Lewd and libidinous practices will now be classified as Sexual assault.


The introduction of the new legislation resulted in some crimes that would previously have been classified as either Breach of the peace etc. or Other miscellaneous offences being classified as Sexual offences. Most of these are now classed as Other sexual offences. However, it is not possible to quantify the number of crimes that this change affects.

Any Sexual offence which occurred prior to 1 December 2010 will be recorded in line with the appropriate legislation in place at that time. If the conduct occurred both prior to and after 1 December 2010 the appropriate offences under the old and new legislation are recorded. Caution should therefore be taken when comparing Sexual offences with previous years.

4. Commentary: Recorded crime in Scotland

4.1 The total number of crimes recorded by the police in 2011-12 was 314,186, 3% lower than in 2010-11 (Chart 1 and Table 1). The total remains well below the 2004-05 figure of 438,123 and is the lowest number recorded since 1975.


Chart 2: Crimes recorded by the police by crime group, 1971¹ to 1994 then 1995-96 to 2011-12

- 4.2 The number of Non-sexual crimes of violence recorded by the police decreased by 17% between 2010-11 and 2011-12 to total 9,533. (Chart 2 and Table 1). Within this category, the number of crimes of Attempted murder and serious assault recorded decreased by 15% to 4,693 and recorded Robberies decreased by 12% to total 2,244. Other non-sexual crimes of violence decreased by 24% from 3,266 to 2,475, mainly driven by a decrease in the number of crimes of Threats and extortion, and Child cruelty. The number of Homicides recorded by the police (which includes Murder, and Culpable homicide, which includes Causing death by dangerous driving, Causing death by careless driving while under the influence of drink or drugs, Causing death by careless driving and Corporate homicide) fell by 1 between 2010-11 and 2011-12 to 121.
- 4.3 The number of crimes in the Sexual offences group increased by 10% from 6,696 in 2010-11 to 7,359 in 2011-12 (Chart 2 and Table 1). Crimes of Rape and attempted rape and Other sexual offences increased by 13% and 48% respectively, while crimes of Sexual assault and Offences associated with prostitution decreased by 10% and 2% respectively. The implementation of the Sexual Offences (Scotland) Act 2009 on 1 December 2010, resulted in a redistribution of Group 2 crimes among the subcategories. Comparisons over

- time of the breakdown of Sexual offences should therefore be treated with caution.
- 4.4 The number of Crimes of dishonesty decreased by 1%, to stand at 154,337 crimes in 2011-12 (Chart 2 and Table 1). The decrease can be largely attributed to four subcategories of Crimes of dishonesty. Housebreaking decreased by 3% to stand at 24,222, Theft by opening a lockfast place (OLP) decreased by 13% to stand at 3,529, Theft from a motor vehicle by OLP decreased by 5% to 8,988 and Theft of a motor vehicle decreased by 19% to 7,060. These decreases were offset by an increase in the number of crimes of Other theft recorded, where there was an increase of 3% from 64,680 in 2010-11 to 66,681 in 2011-12.
- 4.5 Recorded cases of Vandalism (including Fire-raising and Malicious mischief) decreased by 8% to total 75,201 in 2011-12 (Chart 2 and Table 1). Within this category, the number of crimes recorded within the Fire-raising subcategory decreased by 5% to stand at 3,755 in 2011-12. The number of crimes in the Vandalism etc. subcategory decreased by 8% from 78,054 in 2010-11 to 71,446 in 2011-12.
- 4.6 There was an increase of 1% in the Other crimes group (Chart 2 and Table 1). Recorded Drug crimes increased by 2% from 34,347 in 2010-11 to 35,157 in 2011-12. This increase was driven by a 5% increase in the crimes of Possession of drugs. In 2011-12 there were 28,326 crimes of Possession of drugs recorded compared to 26,960 in 2010-11 (Table A6). For the third year in a row there was a notable decrease in the number of crimes of Handling an offensive weapon, which fell by 10% to stand at 5,631 in 2011-12.
- 4.7 The number of crimes of Domestic housebreaking recorded per 10,000 population was highest in North Ayrshire (56), Glasgow City (53), Inverclyde (52) and Renfrewshire (51) in 2011-12. Rural areas recorded much lower levels with Orkney Islands (1), Eilean Siar (5) and Shetland Islands (8) recording the lowest level of Domestic housebreaking per 10,000 population in 2011-12 (Chart 5 and Table 8).
- 4.8 There was a decrease of 1% in the number of crimes cleared up by the police from 156,943 in 2010-11 to 155,264 in 2011-12 (Table A1). However, the clear up rate of crimes (Table 3), has remained at 49% for the fourth year in a row.
- 4.9 The clear-up rate in 2011-12 for Non-sexual crimes of violence was higher than in 2010-11, increasing from 72% to 75% (Table 3). The rate for Sexual offences increased by 1 percentage point between 2010-11 and 2011-12 to 67%. The clear up rate for Miscellaneous offences also increased by 1 percentage point to 84% in 2011-12 compared to 2010-11. The clear up rates for Crimes of dishonesty, Vandalism (including Fire-raising and Malicious mischief) and for Other crimes all remained at the same level in 2011-12 as in 2010-11.

Chart 3: Clear up rates for crimes recorded by the police by crime group, 1976¹ to 1994 then 1995-96 to 2011-12



- 4.10 The number of offences recorded increased by 3% from 530,249 in 2010-11 to 544,033 in 2011-12 (Chart 1 and Table 2). The number of Miscellaneous offences recorded increased marginally in 2011-12 compared to 2010-11, the increase was less than 1%. Within Miscellaneous offences the number of Common assault offences and Other miscellaneous offences decreased by 2% and 1% respectively. The number of Breach of the peace offences (which includes offences of Threatening or abusive behaviour, Offence of stalking, Offensive behaviour at football and Threatening communications (Offensive Behaviour at Football and Threatening Communications Act 2012)) increased by 4%. The number of Motor vehicle offences increased by 4% between 2010-11 and 2011-12. The increase was driven by an increase in Speeding offences and Vehicle defect offences. Speeding offences increased from 114,129 in 2010-11 to 125,221 in 2011-12, an increase of 10%. The increase in Vehicle defect offences was also 10% where the number of offences increased from 21,921 in 2010-11 to 24,094 in 2011-12.

5. Commentary: Recorded crimes and offences by police force

This section provides commentary on the published figures by police force area.

Chart 4 shows that the number of crimes recorded per 10,000 population is higher in police forces which contain large cities, such as Strathclyde and Lothian and Borders, and lower in primarily rural police force areas such as Dumfries and Galloway, and Northern.

5.1 Central

The total number of crimes recorded by Central Scotland Police decreased by 4% between 2010-11 and 2011-12 to 16,257. Following an increase last year, the number of crimes recorded is now below the level recorded in 2009-10, where 16,402 crimes were recorded. Decreases were recorded in four of the five crime groups, the exception being Sexual offences where there was an increase of 20%.

The increase in the Sexual offences group between 2010-11 and 2011-12 was driven by a 85% increase in Other sexual offences.

The number of offences recorded in Central increased by 6% between 2010-11 and 2011-12. The increase in offences was driven by an 14% increase in Breach of the peace etc. and a 14% increase in Vehicle defect offences. Clear up rates for all crime groups were above or the same as the Scotland figure, the clear up rate for Other crimes was the same at 98%. But among all five crime groups the clear up rate recorded by Central Scotland Police

decreased between 2010-11 and 2011-12. The largest decrease was 4 percentage points reported for both Non-sexual crimes of violence and crimes of Vandalism (including Fire-raising and Malicious mischief).

5.2 Dumfries & Galloway

Crimes recorded by Dumfries and Galloway Constabulary decreased for the seventh year in succession and overall by 11% since 2010-11 to total 6,036. Only Sexual offences increased in 2011-12 compared to 2010-11, where there was an increase of 52%. This increase was as a result of increase in crimes of Sexual assault and Other sexual offences. The largest decrease reported was 16% for both Crimes of dishonesty and Vandalism (including Fire-raising and Malicious mischief). It should be noted that as Dumfries and Galloway Constabulary is the smallest police force the actual number of crimes recorded is small in comparison to larger forces such as Strathclyde Police or Lothian and Borders Police.

There was an increase of 2% in offences recorded by Dumfries and Galloway Constabulary. However there was a reduction in the miscellaneous offences category of 6%. The increase in the number of offences recorded was driven by a 4% increase in Motor vehicle offences.

The clear up rates for Sexual offences (85%), Crimes of dishonesty (60%) and Vandalism (including Fire-raising and Malicious mischief) (54%) were the highest rates recorded across all forces in 2011-12.

5.3 Fife

The number of crimes recorded by Fife Constabulary decreased for the seventh consecutive year and overall by 5% between 2010-11 and 2011-12 to total 17,848. There were decreases across all crime groups with the exception of Other crimes, which increased by 6%.

There was an increase of 1% in the number of offences recorded by Fife Constabulary. Within offences there was an increase of 6% in the number of Miscellaneous offences recorded and a decrease of 2% in the number of Motor vehicle offences. The increase in Miscellaneous offences was largely as a result of a 27% increase in Other miscellaneous offences, while the decrease in Motor vehicle offences was driven by a 9% decrease in Speeding offences.

The clear up rates increased across all crime and offence groups between 2010-11 and 2011-12, with the exception of Sexual offences and Other crimes which showed a 3 percentage point and 1 percentage point decrease respectively. The clear up rate for Non-sexual crimes of violence increased by 9 percentage points between 2010-11 and 2011-12 and is now the highest in Scotland, 22 percentage points above the Scotland figure.

5.4 Grampian

The number of recorded crimes in the Grampian Police force area decreased by 5% between 2010-11 and 2011-12 to total 29,226 crimes. Decreases were recorded in all five crime groups between 2010-11 and 2011-12, with the Nonsexual crimes of violence group decreasing by 21%. The decrease in Sexual offences was minimal with the number of crimes only decreasing by 4 between 2010-11 and 2011-12.

The total number of offences recorded by Grampian Police remained broadly the same in 2011-12 as in 2010-11. The number of offences decreased from 54,292 in 2010-11 to 54,099 in 2011-12, the decrease being less than 1%.

The overall crime clear up rate for Grampian Police decreased by 1 percentage point between 2010-11 and 2011-12, leaving the overall crime clear up rate 1 percentage point lower than the Scotland figure. The clear up rates for Crimes of dishonesty (1 percentage point), Vandalism (including Fire-raising and Malicious mischief) (3 percentage points) and Other crimes (1 percentage point) all decreased. The clear up rates for Non-sexual crimes of violence (3 percentage points) and Sexual offences (2 percentage points) both increased. The clear up rate for Other miscellaneous also increased by 2 percentage points between 2010-11 and 2011-12.

5.5 Lothian & Borders

Recorded crime in the Lothian and Borders Police force area decreased by 4% in 2011-12. The number of crimes decreased from 60,167 in 2010-11 to 57,471 in 2011-12. Decreases were reported in four of the five crime groups. The largest decreases were seen in Non-sexual crimes of violence, where the decrease was 10%, and Other crimes, where the decrease was 11%.

The crime group where there was an increase in the number of crimes was Sexual offences. The increase between 2010-11 and 2011-12 was 30%. Within Sexual offences each of the subcategories showed increases of at least 9%. Offences associated with prostitution increased by 50% and Other sexual offences increased by 78%.

The number of offences recorded by Lothian and Borders Police decreased by 4% between 2010-11 and 2011-12. Within the two offence groups Miscellaneous offences increased by 1% while Motor vehicle offences decreased by 6%. Speeding offences did increase by 9% but this was more than offset by a reduction of 18% in the number of Other motor vehicle offences which reduced from 19,312 in 2010-11 to 15,872 in 2011-12.

The overall clear up rate for crimes for Lothian and Borders Police was 44% in 2011-12, 5 percentage points lower than the Scotland figure. The clear up rates increased for Non-sexual offences of violence and Crimes of dishonesty both increasing by 1 percentage point while the clear up rate for Vandalism (including Fire-raising and Malicious mischief) increased by 2 percentage points. Despite the large increase in the number of Sexual offences the clear up rate remained at 66% in 2011-12, the same as in 2010-11.

5.6 Northern

The number of crimes recorded by Northern Constabulary remained broadly the same in 2011-12 as in 2010-11. There was a decrease of 28 crimes, which equates to a decrease of less that 1%. Northern Constabulary reported reductions in four of the five crime groups, the largest being the reduction of 14% for Sexual offences. These reductions were mainly offset by an 11% increase in Other crimes. This increase was driven by a 19% increase in the number of Drug crimes.

There was a 4% increase in the number of offences recorded by Northern Constabulary in 2011-12 compared to 2010-11. Miscellaneous offences increased by 3% and Motor vehicle offences increased by 5%. Within Miscellaneous offences there was an increase of 9% in the Breach of the peace etc. subcategory but also a 15% decrease in Drunkenness offences. The increase in Motor vehicle offences was driven by a 15% increase in Speeding offences.

The clear up rates for Northern Constabulary increased for all five crime groups as well as Miscellaneous offences in 2011-12 compared to 2010-11. The overall clear up rate for crimes was 67%, which is 18 percentage points higher than the Scotland figure. The clear up rate for Sexual offences increased by 8 percentage points to 81%. This follows a reduction in the clear up rate of 11 percentage points between 2009-10 and 2010-11. The clear up rate for Vandalism (including Fire-raising and Malicious mischief) increased by 7 percentage points and is now at the highest level since 2003-04 when it was also 48%.

5.7 Strathclyde

The number of crimes recorded by Strathclyde Police Force increased by 1% between 2010-11 and 2011-12 to total 154,787. This is the first increase in the total number of crimes since 2006-07 but is still below the level reported in 2009-10. There were reductions in Non-sexual crimes of violence and Vandalism (including Fire-raising and Malicious mischief), the larger decrease being 20% for Non-sexual crimes of violence. There were increases reported for the remaining three crime groups. The number of Sexual offences increased by 12% between 2010-11 and 2011-12.

The total number of offences recorded by Strathclyde Police increased from 255,428 in 2010-11 to 270,176 in 2011-12, an increase of 6%. Miscellaneous offences increased by only 1% whereas Motor vehicle offences increased by 10%. The 10% increase was driven by a 19% increase in Speeding offences and a 9% increase in Other motor vehicle offences.

The clear up rates for all the crimes groups are lower for Strathclyde Police than the Scotland figure, except for Other crimes where they are both 98%. In 2011-12, the clear up rates for three of the five groups increased while the other two remained the same as in 2010-11. The clear up rates for Non-sexual crimes of violence and Sexual offences both increased by 5 percentage points. The clear up rate for Non-sexual crimes of violence was 71%, which is the highest rate in over a decade.

In addition the clear up rate for Miscellaneous offences also increased by 2 percentage points in 2011-12 compared to 2010-11.

5.8 Tayside


The number of crimes recorded by Tayside Police Force decreased for the seventh consecutive year and overall by 16% between 2010-11 and 2011-12 to total 19,005. The 16% decrease was the largest reported among the eight police forces. There were decreases in four of the five crime groups in 2011-12. Non-sexual crimes of violence decreased by 10%, Crimes of dishonesty decreased by 17%, Vandalism (including Fire-raising and Malicious mischief) decreased by 24% and Other crimes decreased by 3%. The only crime group to report an increase was Sexual offences, where the increase was 7%.

For each subcategory within Crimes of dishonesty there was at least an 11% reduction in the number of crimes in 2011-12 compared to 2010-11. The 24% reduction for Vandalism (including Fire-raising and Malicious mischief) was driven by a 25% decrease for Vandalism etc.

The number of offences recorded by Tayside Police decreased by 5% compared with 2010-11. The decrease in the number of offences was driven by a 17% reduction in the number of Miscellaneous offences as there was a 1% increase in the number of Motor vehicle offences. The majority of the decrease in Miscellaneous offences was due to a 27% reduction in Breach of the peace etc. offences.

In 2011-12, Tayside Police reported reductions in the clear-up rates for three of the five crime groups compared with 2010-11. The clear up rate for Sexual offences decreased by 14 percentage points, the lowest clear up rate in over a decade. The clear up rate for Crimes of dishonesty increased by 1 percentage point and the clear up rate for Other crimes remained the same as in 2010-11. With the exception of Sexual offences, following the decrease of 14 percentage points, the clear up rate for the other four crime groups were higher than the Scotland figure in 2011-12. The clear up rate for Miscellaneous remained at the same level as in 2010-11 at 87%, 3 percentage points higher than the Scotland figure.

6. Scottish Crime and Justice Survey

- 6.1 The preceding sections of this bulletin describe the volume and types of crime recorded and cleared up by the eight police forces in Scotland during 2011-12. The recorded crime bulletin series is generally a useful indicator of trends in recorded crime. However, not all crimes are reported to the police and the propensity of the public to report crime to the police also changes over time.
- 6.2 Crime surveys can be a useful source of information by providing a fuller picture of both the extent of, and the trends in most types of household and personal victimisation. The information provided by such surveys complements the information compiled by the police forces, as well as exploring other issues such as the impact of crime on victims, public anxieties and reactions to crime and attitudes towards the police and other parts of the criminal justice system.
- 6.3 Findings from the 2010-11 Scottish Crime and Justice Survey (SCJS), which asked about crimes and offences experienced between the beginning of April 2010 and the end of March 2011 are available at:

- Estimates derived from the 2010-11 SCJS suggest that around 874,000 crimes were committed against individuals and private households in Scotland between 1 April 2010 and 31 March 2011¹. This is 16% lower than estimated in 2008-09. The estimate for 2010-11 suggests that nearly one in five adults (18%) had been the victim of at least one household or personal crime.
- According to the survey, 75% of crimes experienced in 2010-11 were against property with property vandalism accounting for one in three (32%) of all crimes recorded. 25% of crimes were committed against individuals, with 24% involving assaults and 1% involving robbery.
- The 2010-11 survey estimates that 39% of crimes captured by the survey came to the attention of the police. This is higher than the rate of 37% estimated in 2009-10. Where the incident had not been reported to the police, the main reasons given were that the incident was too trivial (40% of unreported incidents), police could not have done anything about it (29%), and police would not be interested (13%).
- Results from the Scottish Crime and Justice Survey 2012-13 are due to be
 available in November 2013. The results will be representative at national level
 and at the level of the eight police forces in Scotland. The findings from the
 survey will be used by policy makers across the public sector in Scotland to
 help understand the nature of crime in Scotland, target resources and monitor
 the impact of initiatives to target crime.



Changes to Sexual offences from 1 December 2010

The implementation of the Sexual Offences (Scotland) Act 2009 on 1 December 2010 has had an effect on the breakdown of Sexual offences. Comparison over time of the statistics in Table A2 should therefore be treated with caution. A number of notable changes took place. Please note however that as the legislation came into place part way through the 2010-11 financial year the data for 2010-11 contains only 4 months of data using the new breakdowns.

- From 1 December 2010 onwards, Sexual assault can be broken down into a number of more specific offences. A further breakdown of Sexual assault is provided in the Table A3 below.
- Lewd and libidinous practices can also now be broken down into more specific offences, relating to children. Over time, we should see this category decrease and disappear altogether.
- Historically, Rape related only to female victims, but the new legislation allows for the recording of male rape as Rape rather than Sexual assault.
- Sexual intercourse with a girl under 16 is another category which in time will become obsolete as more specific Sexual assault categories will be used to record these crimes.
- Indecent exposure now also includes crimes of Sexual exposure

7. Notes on statistics used in this bulletin

Returns

- 7.1 The statistical return from which most of the figures in this bulletin are taken is a simple count of the numbers of crimes and offences recorded and cleared up by the police. Only returns from the eight Scottish home forces are included in this bulletin. One return is made for each council in Scotland and these are aggregated to give a national total. Amendments (such as the deletion of incidents found on investigation not to be criminal) which arise after the end of the financial year are not generally incorporated.
- 7.2 In 1993 information was collected for the first time from other police forces, such as the British Transport Police. This practice has been continued, but these figures have **not** been included in the main body of this bulletin. Thus, in addition to those crimes and offences referred to throughout this bulletin there were in total, 1,891 crimes and 3,252 offences recorded by the British Transport Police, Ministry of Defence Police and Civil Nuclear Constabulary in 2011-12. The crime clear-up rate was 30% and the offences clear-up rate was 45%.
- 7.3 The figures included in the Motor vehicle offences group do not include *stationary* motor vehicle offences dealt with by the issue of a fixed penalty ticket. However, offences dealt with under the vehicle defect rectification scheme and offences for which the procurator fiscal offers a fixed penalty are included in the figures. In addition to this, *moving* traffic offences which are the subject of a police conditional offer of a fixed penalty are also included, e.g. speeding, traffic directions offences.
- 7.4 Under the Code of Practice for Official Statistics, the estimated costs of responding to statistical surveys and data collection are to be published.

The estimated cost of compliance for supplying and validating the data for this bulletin is: £2,300.

Recording issues

7.5 In one criminal incident, several crimes or offences may occur - e.g. a house may be broken into and vandalised and the occupants assaulted. In this example, crimes of housebreaking (which would include the vandalism) and assaults would be recorded. In multiple offence incidents more than one offence may be counted rather than one for the incident as a whole; that is, the counting system is offence based rather than incident based. An offence may have more than one victim - for example in robberies - and be committed by more than one offender - e.g. some assaults and housebreakings (note that for murder, attempted murder and culpable homicide, the number of crimes recorded is equal to the number of the victims). Thus the statistics in this bulletin are not directly comparable with statistics on action taken against offenders, as one offence may lead to several persons being charged.

Equally, an offender may be charged with several offences. The statistics for recorded number of crimes given in this bulletin are also not directly comparable with statistics collected in England and Wales for the recorded number of notifiable offences. This is mainly due to differences in the counting rules; for notifiable offences the counting system is, wherever possible victim based rather than offence based. The Home Office introduced new counting rules for notifiable offences and expanded their coverage on 1 April 1998.

7.6 In Scotland, assault is a common law offence. In order to distinguish between serious and common assaults, police forces use a common definition of what a serious assault is.

"An assault or attack in which the victim sustains injury resulting in detention in hospital as an inpatient, for the treatment of that injury, or any of the following injuries whether or not detained in hospital;

- Fractures (the breaking or cracking of a bone. Note nose is cartilage not bone, so a 'broken nose' should not be classified unless it meets one of the other criteria)
- Internal injuries
- Severe concussion
- Loss of consciousness
- Lacerations requiring sutures which may lead to impairment or disfigurement
- Any other injury which may lead to impairment or disfigurement."

Please note that slight changes to the definition of serious assault were made in April 2011. Loss of consciousness is no longer included in the definition of what constitutes a serious assault.

7.7 Attempts to commit an offence are included in the statistics, in general in the same group as the substantive offence.

Reporting practices

- 7.8 These statistics do not of course reveal the incidence of all crime committed. Not all incidents are reported to the police. The Scottish Crime and Justice Survey (SCJS) 2010-11 estimated that 39% of crimes, as defined by the SCJS, were reported to the police. The two reasons most commonly given by victims for not reporting to the police were that the incident was considered by them to be too trivial (40%) or the police would not have been able to do anything (29%).
- 7.9 Many offences, for example, speeding or possession of drugs, have no victim other than perhaps the perpetrator and are discovered and recorded as a result of police activity rather than by being reported to the police by the public. Hence, the strength and deployment of the police forces mainly determine the numbers of such offences recorded.

Crimes and offences cleared up

7.10 The definition of "cleared up" is noted below. This definition came into force with effect from 1 April 1996.

A crime or offence is regarded as cleared up where there exists a sufficiency of evidence under Scots law, to justify consideration of criminal proceedings notwithstanding that a report is not submitted to the procurator fiscal because either

- (i) by standing agreement with the procurator fiscal, the police warn the accused due to the minor nature of the offence, or
- (ii) reporting is inappropriate due to the non-age of the accused, death of the accused or other similar circumstances.

For some types of crime or offence the case is cleared up immediately because the offender is "caught in the act", e.g. motoring offences. In Scots law, the confession of an accused person to a crime would not in general be sufficient to allow a prosecution to be taken, as corroborative evidence is required. Thus, a case cannot be regarded as "cleared up" on the basis of a confession alone. In some cases there is sufficient evidence but a prosecution cannot be brought, for example, because the accused has left the country. In such cases, the offender is said to have been traced and the crime is regarded as cleared up. The other terms in the definition describe the various actions that must be taken by the police against offenders.

- 7.11 Certain motor vehicle offences are not always recorded in cases where police forces are unable to clear-up the offence (e.g. speeding offences where the driver is untraceable). Clear-up rates for motor vehicle offences in these circumstances are artificial. Thus, clear-up rates for the Motor vehicle offences group are not included in the bulletin.
- 7.12 Clear-up rates in excess of 100% can arise where offences recorded in one year are cleared up during the following year.

Classification

- 7.13 Contraventions of Scottish criminal law are divided for statistical purposes into crimes and offences. "Crime" is *generally* used for the more serious criminal acts; the less serious termed "offences", although the term "offence" may also be used in relation to serious breaches of criminal law. The distinction is made only for working purposes and the "seriousness" of the offence is *generally* related to the maximum sentence that can be imposed.
- 7.14 The detailed classification of crimes and offences used by The Scottish Government to collect criminal statistics contains about 475 codes. These are grouped in the bulletin as shown in Section 8.

7.15 For 2011-12 there have been a number of changes to the standard breakdowns included in the bulletin tables. Group 2 offences, previously called Crimes of indecency, are now referred to as Sexual offences. The crime category Minor assault has been renamed Common assault. In turn the crime codes Minor assault and Minor assault of an emergency worker have similarly been renamed. The crime category Drunk driving has been renamed Driving under the influence to reflect the fact that this category includes driving while under the influence of drugs as well as drink driving.

The crime category Serious assault etc. has been split into two new categories: Homicide and Attempted murder and serious assault. The crime category Prostitution has been replaced by a new category called Offences associated with prostitution. This includes the crimes in the old Prostitution category as well as the following crimes that were previously included in Other sexual offences: Soliciting services of person engaged in prostitution, Brothel keeping, Immoral traffic, Procuration.

The crime category Breach of the peace had been changed to Breach of the peace etc. The category has been renamed as it now includes the following offences in addition to Breach of the peace: Threatening or abusive behaviour, Offence of stalking, Offensive behaviour at football and Threatening communications (Offensive Behaviour at Football and Threatening Communications Act 2012). Threatening or abusive behaviour and the Offence of stalking were classified in the Other miscellaneous offences category in 2010-11. Offensive behaviour at football and Threatening communications (Offensive Behaviour at Football and Threatening Communications Act 2012) are new offences introduced on 1 March 2012 when the Offensive Behaviour at Football and Threatening Communications Act 2012 was implemented.

Overall totals of Crimes and Offences for 2009-10 and 2010-11 have been affected by changes to the categories of Other sexual offences and Other miscellaneous offences. From 2011-12 onwards, the offence of Taking, distribution, possession etc. of indecent photos of children has been reclassified as a Sexual offence. This may result in some minor deviations from the figures reported in police forces' annual reports.

In April 2011 offences of Handling an offensive weapon and Drug crimes in prisons were reclassified from Other miscellaneous offences to offences of Handling an offensive weapon and Drug crimes respectively. For 2011-12 it will not be possible to disaggregate either the offences of Handling an offensive weapon or Drug crimes that took place in prison. From April 2012 this disaggregation will be possible.

7.16 Clearly, only a limited selection of tables can be included in any statistical bulletin. Further analysis of recorded crime statistics can be supplied on request. This includes available information relating to time periods other than those covered in the bulletin. In certain cases a fee is charged.
